We have updated our Masking and Covid policy in accordance with the most current protocols issued by the [Alameda County Public Health Department on June 3rd](#). Please share this information with those who are authorized to pick up your child(ren) as designated on your child's identification form.

Please review and save the following program updates:

Masking

- Alameda County Public Health Department has reinstated their masking mandate in all schools, childcare, and camps.
- Students, parents, and staff must remain masked while on campus until the mandate is lifted.

Health Screening

- Each family is required to screen their own child(ren) BEFORE arriving to school each day to verify that your child is healthy and well enough to attend a full day of school (Cleared4School App is no longer in use)
- Students will be denied entrance to school in the event that they appear unwell

Illness/Sick Policy

- Your child should not attend school when exhibiting these symptoms:
 - Fever (out for 24 hours, minimum)
 - Diarrhea (out for 24 hours, minimum)
 - Vomiting (out for 24 hours, minimum)

Students with the following mild symptoms may attend provided a negative test result is taken the morning of symptoms.

Email photographic proof of the negative test. Child's name and date must be written on the test result.

Thick congestion / runny nose (Students with allergies: provide a letter from your child's physician indicating current allergy and plan of action)

Severe headache

Cough

Sore throat

Difficulty breathing

New loss of taste or smell

-If you have questions or concerns about safely returning to school program, please contact the office at (510)582-3273 or info@woodroewoods.org

-Children's health will be closely monitored. If your child becomes ill while at school, we will notify you immediately and your child will need to be picked up within the hour

Covid Policy/Protocols

-If your child tests positive for Covid they are to remain home a minimum of 5 days and then must test negative via antigen test on day 6 to return to school. In the event the masking mandate is dropped, your child is to remain masked for a total of a 10 day period. Day of a positive test is considered day zero(0). Students must also be fever free for 24 hours without the use of fever-reducing medication.

-If symptoms, other than fever, are not resolving, continue to isolate until symptoms are resolving or until after day 10.

-If your child has been exposed to a Covid positive individual outside the program, you must keep them home for 24 hours of observation, to determine if symptoms arise, and then provide a negative test before returning to school.

-You will be notified of any reported Covid exposures within the program, and your child may remain in attendance if they are symptom free.

-With any potential Covid exposures, it is highly recommended to test your child 3-5 days after exposure
